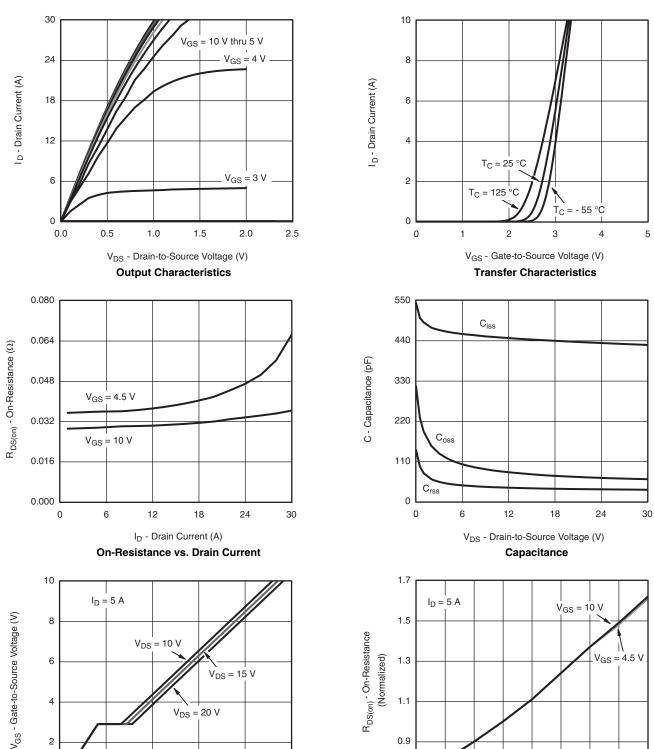

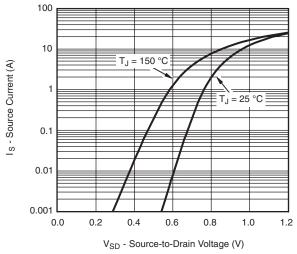

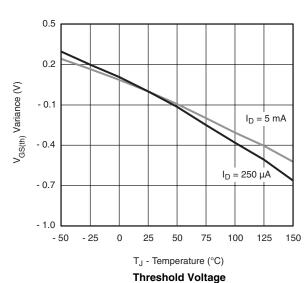

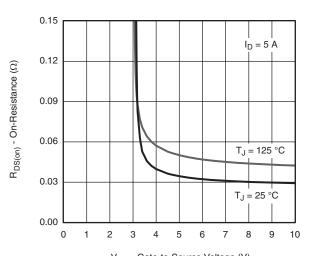

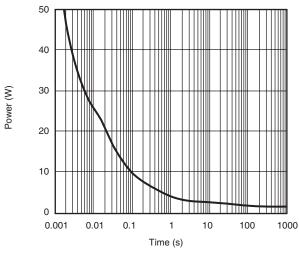
Source-Drain Diode Forward Voltage



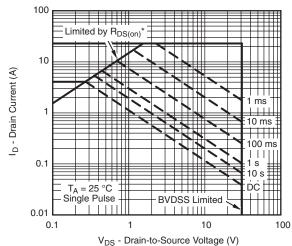


V_{GS} - Gate-to-Source Voltage (V)

Single Pulse Power

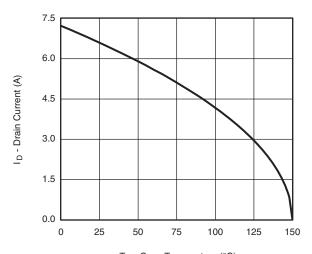

Safe Operating Area, Junction-to-Ambient



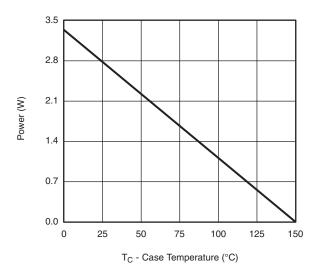

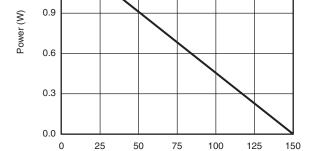
T_C - Case Temperature (°C)

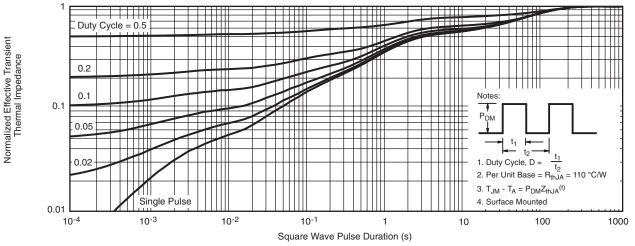

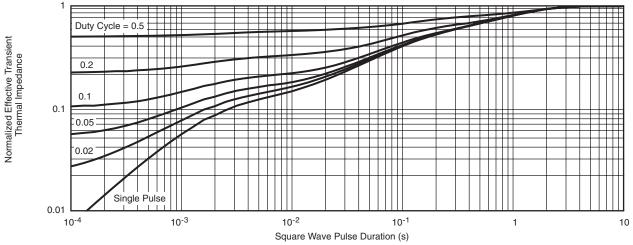
