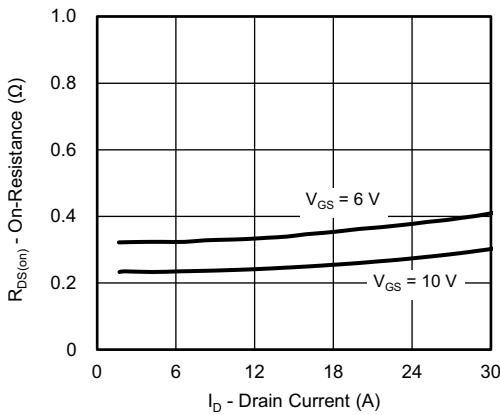

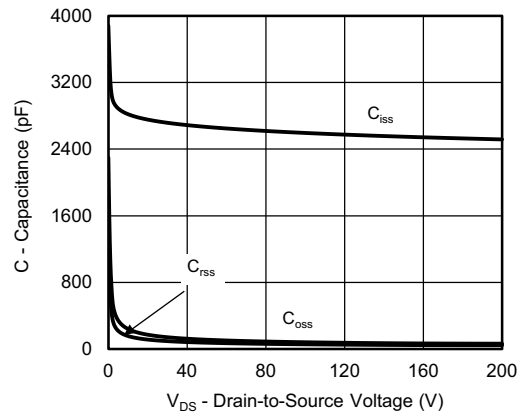

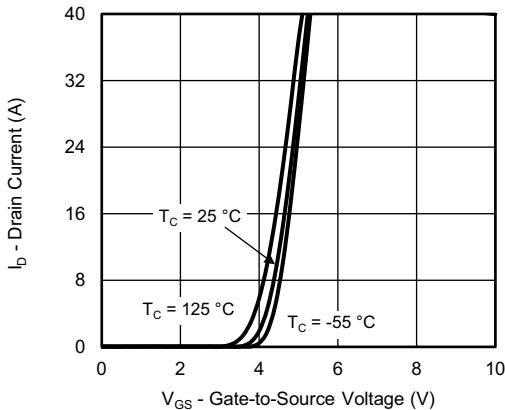
Transconductance



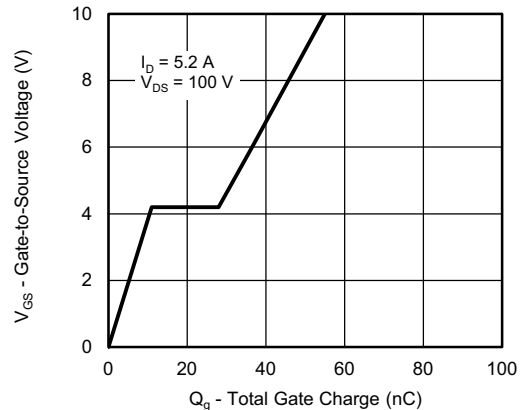
On-Resistance vs. Drain Current



Capacitance

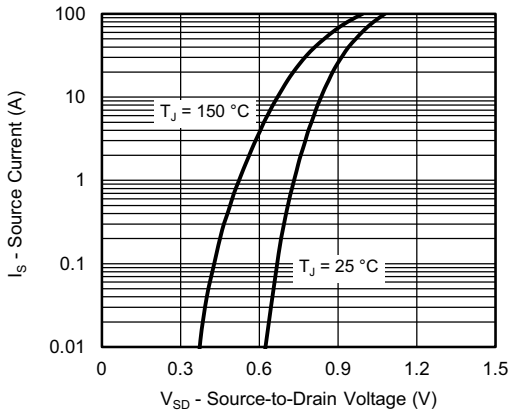

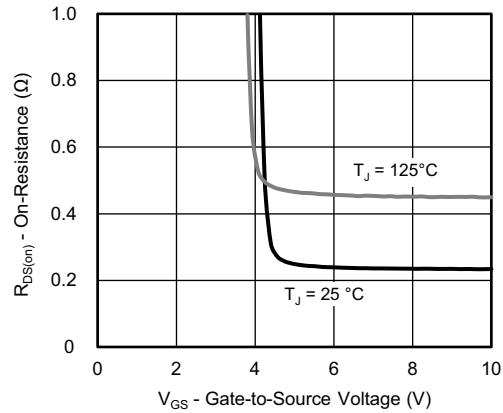

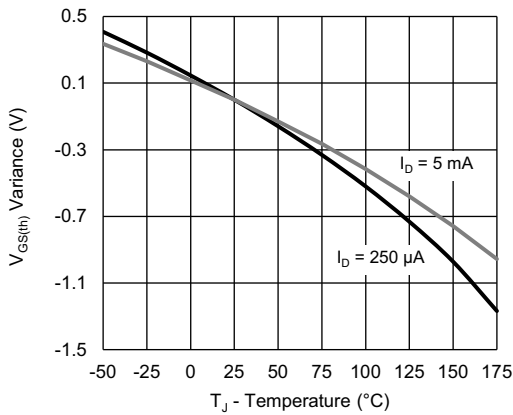

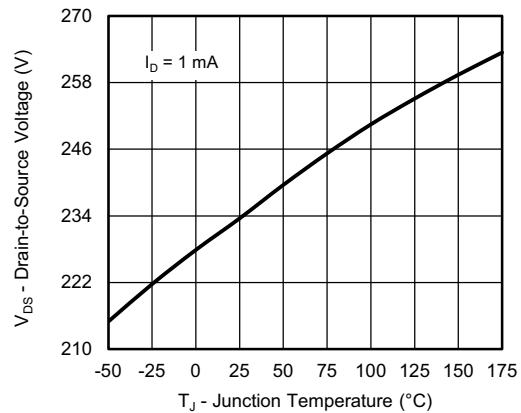
**Source Drain Diode Forward Voltage**



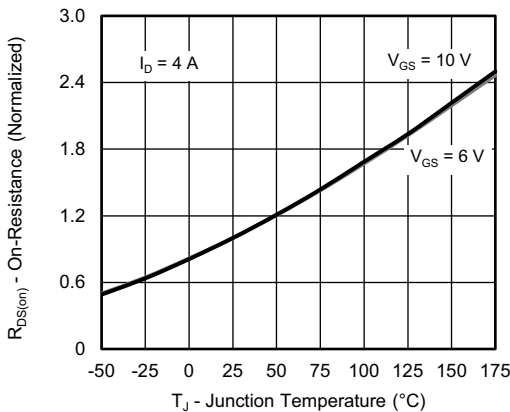
**On-Resistance vs. Gate-to-Source Voltage**



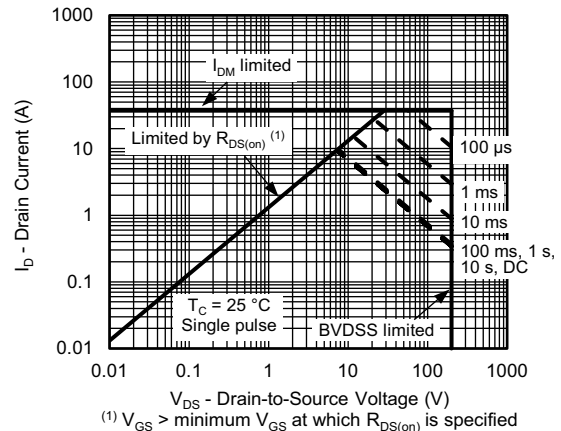
**Threshold Voltage**



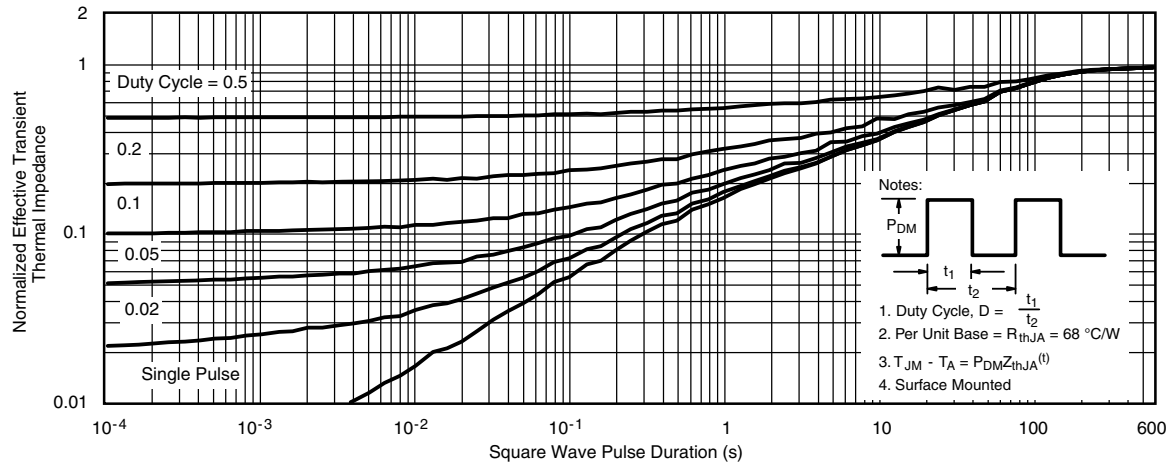
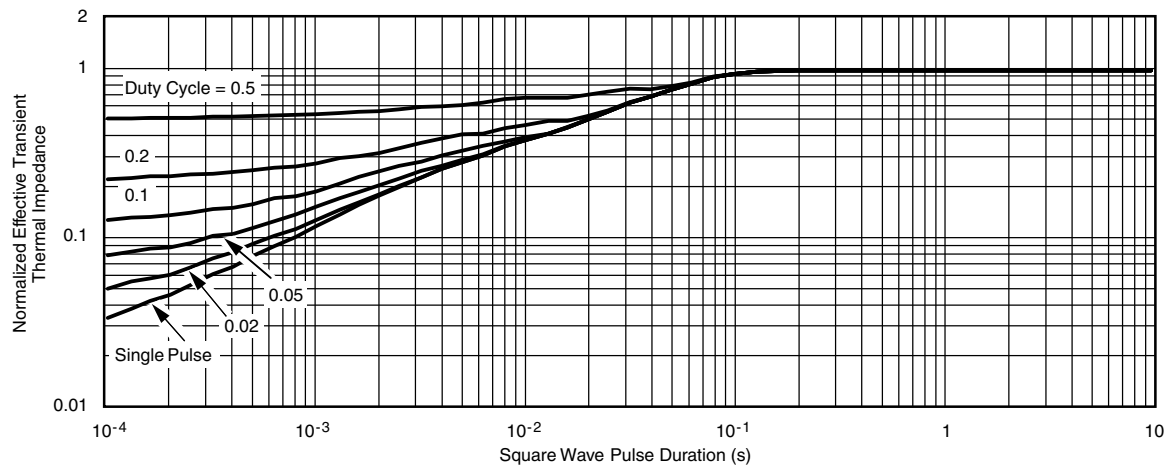
**Drain Source Breakdown vs. Junction Temperature**

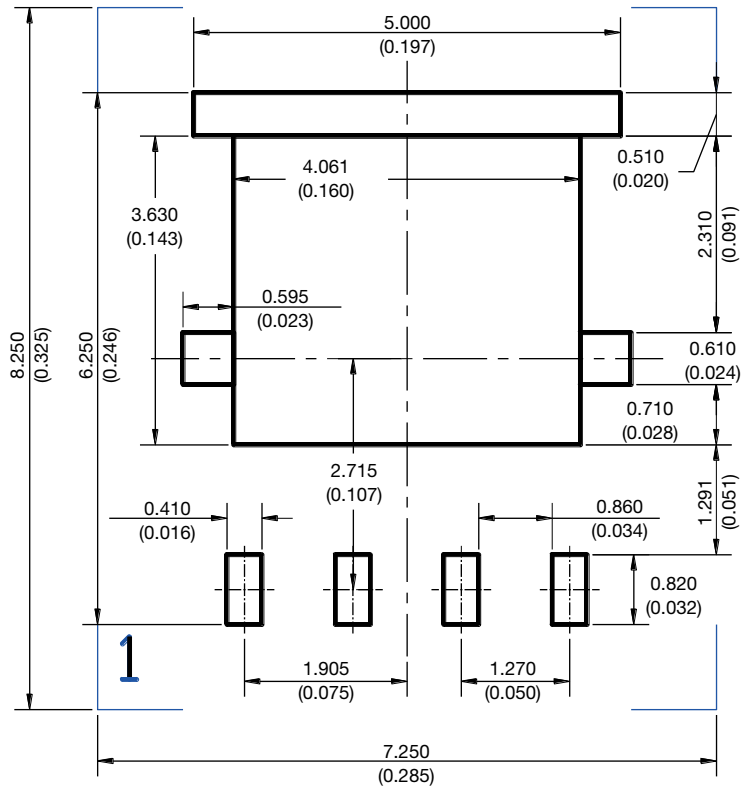
