### Typical Inductance vs. Frequency Characteristics:



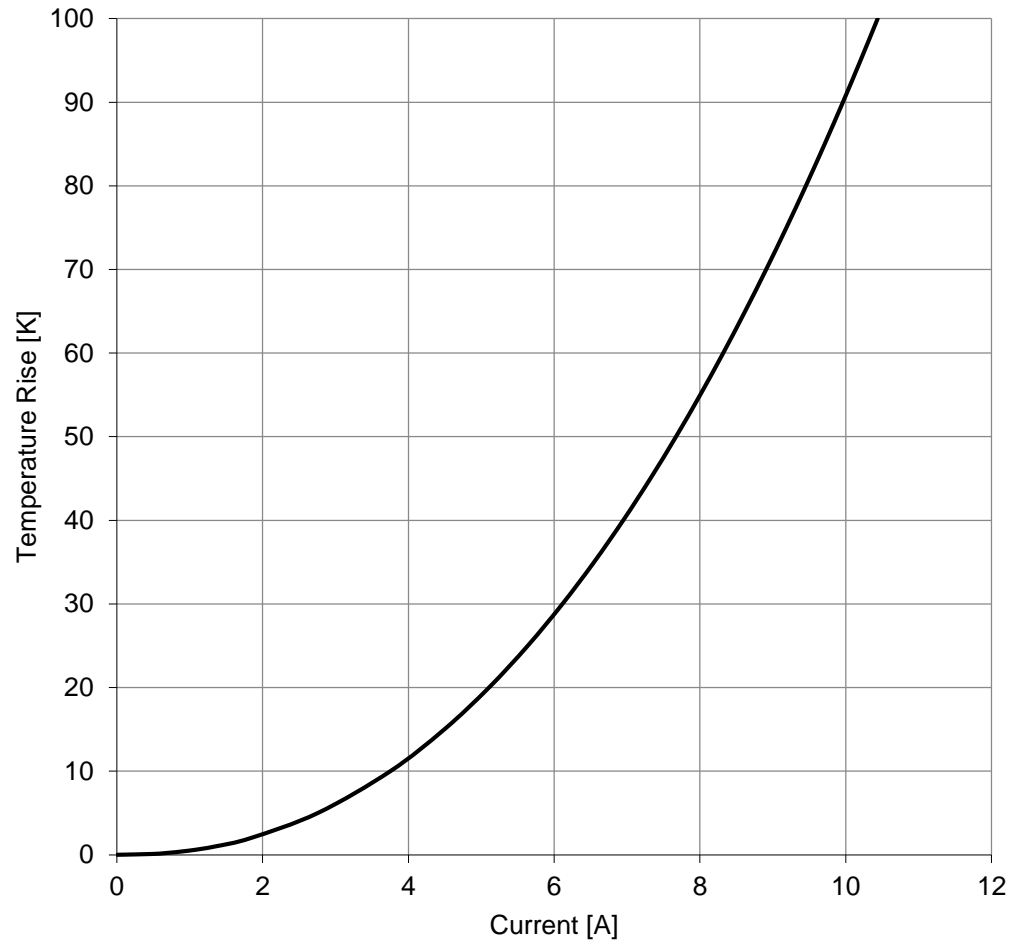
### Typical Inductance vs. Current Characteristics:







#### Soldering:




