





SN54F10 ... J PACKAGE SN74F10 ... D OR N PACKAGE (TOP VIEW)




SN54F10...FK PACKAGE (TOP VIEW)

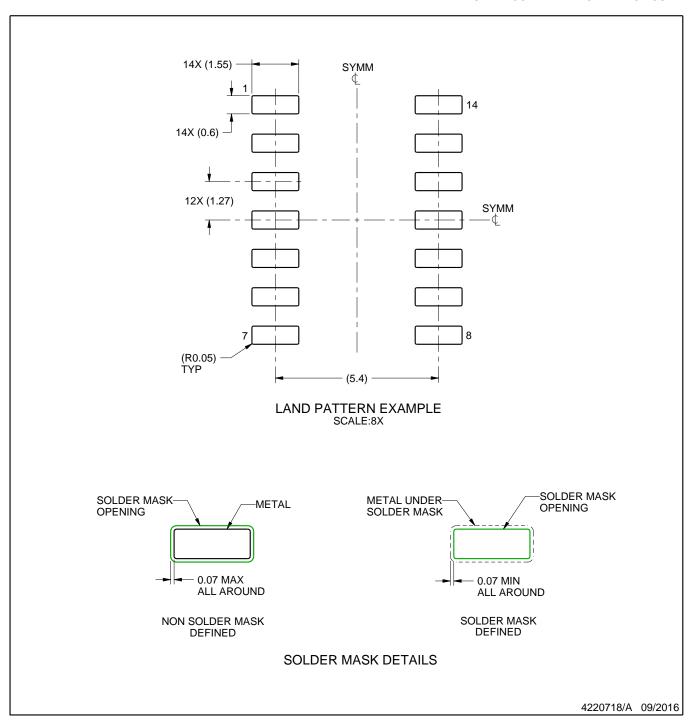
